

Treasurer's Report

for the year ended 31 March 2025

Statement of Financial Performance - Income and Expenses

Income – Down slightly on last year by \$1,714.

Membership numbers are up on last year, although income is down slightly. We currently have 97 paid up memberships, which includes 6 family groups. An increase in Associate membership, mainly from previous Senior Members, is the main reason for the decrease in income.

Interest income is down on last year by \$508 reflecting the decrease in interest rates.

Donations totalled \$5,464, emanating mainly from donated model sales \$5,068, Warbird Caps \$390.

Warbird's Profit (income less expenses) was \$5,355, nearly doubling from last year. This was due to the increased per car parking donation and landing fees, and the great Hawke's Bay weather that brought the public out.

Expenses – Total expenses increased by \$3,360 mainly due to shed and shelter maintenance and post flood repairs. Insurance costs incurred only a small increase though it is expected they will increase in future years.

Net Income – MFHB made a cash surplus of \$6,785.65, and a Net Loss of \$1,052 due to Asset Depreciation.

Statement of Financial Position – Asset and Liabilities

No significant change in Net Assets: \$140,838. Funds were moved from the John Deans' Account to pay for the repairs to the shelter after damage from Cyclone Gabriel.

The year gone by has been a stable year for the Club in financial terms. We still have good cash reserves of \$36,087 on call and \$49,751 in term deposits.

I would like to express my appreciation for the continued support I have received from, in particular my wife Lee, in preparing these accounts, Committee Members and Members generally, in my role as Treasurer.
